PRODUCT DESCRIPTION

FAKOLITH FK-111 is a concentrated liquid cleaner, alkaline solution that can easily dissolve dirt or grime in multiple surfaces resistant to alkaline solutions.

PROPERTIES

Water-based, biodegradable, chlorine and formaldehyde free. Due to its fluidity, high concentration and excellent miscibility can be used to clean almost all kinds of dirt, in almost all types of alkali-resistant surfaces, effectively elimination of greases, oils, soot and industrial dirt, pollution and atmospheric contamination in general, and can even be applied to help to remove certain types of common salts and limes, scrapes and abrasions, gums ...

FOR USE ON

Generally in all kind of insensitive alkalinity surfaces, such as natural and artificial stone, ceramic tile, mortar, concrete, precious metals, stainless steel, plastics, alkali-resistant painted and lacquered surfaces (Especially when it is applied in concentrate).

In industry, facades and restoration works, parkings, maintenance of vehicle fleets, machinery, trains, supermarkets, warehouses, workshops, airports, leisure centers, restaurants, hotels, kitchens ...

SENSITIVE SUBSTRATE

Surfaces of weak metal alloys such as aluminum, can suffer a gloss loss after cleaning with FK-111, all depending on the concentration used, in higher water dilution, lesser degree gloss loss. The same happens to the galvanized steel and some bright paints with low resistance to alkalinity and some shiny synthetic materials. Although FK-111 may be a suitable cleaner on these surfaces, as a pretreatment before primer and paint, it could be not recommended if what you want is simply cleaning and maintaining the original gloss of these delicate surfaces.

In case of doubt, do preventive tests in an inconspicuous place.

APPLICATION

- Before starting to clean cover with plastic the surfaces that should not be treated, especially those sensitive to alkalinity.
- It is recommended to apply the concentrate and / or its dissolution with synthetic bristle brush, spray, sponge, or by suitable machinery, resistant to alkaline solutions.
- Depending on the degree of dirt, firstly rub with a brush insisting in dirtier areas and let the product acts (emulsify) between 10 and 30 minutes. Then rinse off with water, and if it is possible applied with pressure. For special cases, please contact our technical advisory service.
- Rinse with water before the product and dissolved dirt dries.
- Allow to dry before proceeding with other treatments.
- · Repeat application promptly where will be necessary.

PERFORMANCE

Depending on the degree of soil or grime to be cleaned, dilute the product in water as follows (always test solution before use in each case):
